Introduction

The Advanced Placement (AP) Program and the International Baccalaureate (IB) Diploma Programme are advanced academic programs that make rigorous, college-level academic content

questions (College Board, 2012a). The only exception to this format is AP Studio Art, which has a portfolio assessment, rather than an examination. In addition to the free-response and multiple-choice sections, the language examinations include a speaking component, and the AP Music Theory examination includes a sight-singing task. Examinations vary in length, and scores range from 1 to 5 (Table 1). AP examinations are administered each year in May.

AP and IB courses can be one or more semesters in length. For a course that extends over more than one semester, completion of the course is defined as successful completion of all semesters of the course. For example, a student is counted as having completed AP United States History, a two-semester course, only after completing both the first and second semesters of the course. In addition, successful completion of a course requires a student to meet "... the standard requirements of the course, including demonstrated proficiency in the subject matter ..." (Title 19 of the Texas Administrative Code §74.26, 2012).
